FEDERAL ENERGY TAX CREDIT DEALER INFORMATION:

- ∞ The 30% Federal Income Tax credit applies to energy saving improvements including eligible building envelope components.
- ∞ To be eligible the garage door must have an installed U-factor equal to or less than 0.30 and the garage door must be installed with a perimeter seal, such as vinyl door stop on the sides and top and bottom astragal.
- ∞ The following Midland Garage Door models are eligible:

Standard Raised Panel-----2” Thermo-Steel

Classic Panel-----2” Thermo-Steel

Carriage House-----2” Thermo-Steel

Ranch Panel-----2” Thermo-Steel

THE GARAGE DOOR MAY INCLUDE WINDOWS USING OUR ½” INSULATED GLASS.

- ∞ The maximum credit for the taxpayer is \$1,500 under this act for all energy saving improvements. Taxpayers that used their full \$1,500 credit in prior years are no longer eligible .
- ∞ The credit only applies to the cost of the product (it does not apply to the cost of installation)
- ∞ The garage door must be installed in an existing home which is the taxpayer’s primary residence.
- ∞ The garage door must be installed in an insulated garage.
- ∞ The garage door must be installed between January 1, 2009 and December 31, 2010.
- ∞ The garage door must be expected to remain in service for at least 5 years.
- ∞ The taxpayer must complete Midland Garage Door’s **ENERGY TAX CREDIT CERTIFICATION** form and retain the form with personal tax records. The form should not be filed with the tax return.
